

- Side walk seating must be located within the business's boundaries. If seating extends to the abutting property owner or an additional area adjoining the owned or leased property written permission is required by the property owner. The size of the additional area may not exceed the principal area owned or leased by the licensee. A permission letter must be submitted with this application.

▪ Please submit application to the Town Clerk's office no later than 10 days prior to the first Council Meeting in April.

- For businesses located where the Maine Street sidewalk has been upgraded to the brick/concrete combination, measure 5 feet (60 inches) inward from the outer edge of the concrete (nearest the road). The area between the building and this 5-foot mark can be utilized, with a vertical clearance of 8 feet (96 inches).



- For businesses where the sidewalk has yet to be upgraded, there needs to be a 5 foot (60 inches) paved clearance for pedestrian travel between outdoor seating any curb or fixed sidewalk appurtenances such as, but not limited to, tree wells, lamp posts and fire hydrants. With a vertical clearance of 8 feet (96 inches).

- The 5 feet (60 inches) must be maintained for ADA compliance.

Initial

- Businesses that do not include outdoor waiter services must provide waste and recycling receptacles and must be maintained regularly.
- Non-Compliance puts your business in violation of the sidewalk seating ordinance Chapter 10; Article II and may result in citations, fines and/or revocation of your permit to sell prepared food on a public way.
