TAXPAYER'S NOTICE

As per state statute, the ownership and valuation of all real and personal property subject to taxation is fixed as of April 1, 2023. Real estate taxes are due in two installments with the first due 10/31/2023, and the second due 04/16/2024. Personal property taxes are due in a single installment on 10/31/2023. INTEREST AT THE RATE OF 8% PER ANNUM IS CHARGED ON ALL TAXES UPON AS OF THE DUE DATE(S). Collection is enforced in accordance with Maine law. This bill is only for the current tax year, and does not include any past due amounts.

FOR OWNERS APPROVED FOR THE SENIOR PROPERTY TAX STABILIZATION PROGRAM, AN ADJUSTMENT HAS BEEN MADE TO THIS BILL.

Your tax bill has already been reduced by approximately 29.5% due to funding the Town of Brunswick anticipates will be received from the State of Maine in the form of Revenue Sharing, Education Aid, and reimbursements for portions of the Homestead and Business Equipment Tax Exemptions. As of June 30, 2023, the amount of the Town of Brunswick's principal debt outstanding was \$51,732,412.
